



NOTICE OF ELECTIONS FOR CONDUCTOR/TOWER (B) DIVISION - VICE CHAIR POSITION

In accordance with the Constitution of the Transport Workers Union of America, Local 100's By-laws, and the Election Rules, the election to fill a Division Vice-Chair, position in the Conductor/Tower B Division, will take place by secret mail ballot mailed out on Friday, October 30, 2020, to all those who are members of Local 100 in good standing. The term of office will be for the remainder of the unexpired term which will end December 31, 2021. The election results will be posted on the TWU Local 100 website.

THE MAILING

Ballots will be mailed out on **Friday, October 30, 2020**, by the Elections Committee, utilizing the most recent membership list available. The address of the mailing and assembling of ballots is, **H & H Graphic Printing, 400 Gotham Parkway, Carlstadt, N.J. 07072.**

To be eligible to vote in the election and be mailed a ballot, a member must be in good standing and must have paid all arrears in dues and other financial obligations to the Union, prior to voting, in accordance with Article XIII of the Constitution of the Transport Workers Union of America, AFL-CIO. Any member who is not in good standing may pay his/her arrears and request a ballot from the Elections Committee at 212.873.6000 ext. 2090. Ballots received from such members will be counted.

THE COUNT

The count of the ballots returned will commence at 8:30 AM on **Monday, November 23, 2020**, on the 3rd Floor, of the **Transport Workers Union Headquarters, located at 195 Montague Street Brooklyn, N.Y., 11201** or at another location chosen by the Elections Committee, in consultation with the Elections Committee Counsel, and will continue until completed, with such breaks for meals and rest as the Elections Committee may decide. Any member who is not in good standing may pay his/her arrears and request a ballot from the Elections Committee at 212.873.6000 ext. 2090. Ballots received from such members will be counted.

No ballot which is received in the PO Box. after 8:30 AM on Monday, November 23, 2020 shall be counted. NO WALK IN BALLOTS WILL BE ACCEPTED; BALLOTS MUST BE RETURNED TO THE PO BOX.

OBSERVERS

Each candidate may designate in writing, signed by him or her, any member in good standing to act as their observer at each step in the election process, including: the assembling of ballots at the printer; the picking up of ballots from printers and their transportation to the Post Office for mailing; the ballot pick up from the post office; the eligibility check and the count on **Monday, November 23, 2020**. An individual candidate may not be represented by more than one observer at any one time, except at the count. At the count a candidate may have the same number of observers as there are stations for counting. A candidate may be one of the allowed observers.

Depending on any public health regulations or concerns that may exist on November 23, 2020, the Elections Committee retains the right to limit the number of observers or to permit observers to observe remotely rather than in person or to make any other changes in procedure it deems necessary.

DUPLICATE BALLOT REQUESTS

Any member who does not receive a ballot by **November 5, 2020**, should contact the Elections Committee, **Monday through Friday, 9:00 a.m. - 5:00 p.m.**, at **(212) 873-6000 ext. 2090**. Requests for replacement ballots must be made by no later than **5:00 p.m. on Wednesday, November 18, 2020**. If two ballots are received from the same member, the one received last will be the one counted.

DUES

If you do not know if the union considers you to be a Good Standing member (**must have no outstanding dues arrears**), eligible to nominate, or run for office, or vote, you must check with the union. To do so, and/or to bring yourself into Good Standing, please call the Dues Department at 212-873-6000 ext. 2084.

CHANGE OF ADDRESS

All members who have moved or changed their address and have failed to notify TWU Local 100 of such change should notify the **General Office at 212.873.6000**. **It is the responsibility of the member to keep the Union updated on his/her current address.** Also, this will allow TWU Local 100, to be current with keeping an accurate list of our membership and to properly send information to the correct address.
